Please read the following frequently asked questions for Property Management carefully then sign and date before submitting your application:

- What is the process if I wish to rent a property?
 - > If you would like to rent a property you will need to complete an Application for Tenancy. Once your application is approved we will then schedule an appointment to view available properties for rent.
- Do you show available rentals during evenings or on weekends?
 - No, the reason for this is to minimize the disruption to any current tenants. All showings will take place Monday to Friday between 10 AM and 4 PM. For vacant properties we will consider Saturday showings between Noon and 3 PM if the appointment is previously arranged prior to that day.
- How long will it take to have my application approved?
 - ➤ We endeavor to process the application upon receipt when we have properties available. Please ensure your application is complete and that your employer, previous landlord and references are aware we will be contacting them. At times we receive several applications from prospective tenants. If we are unable to reach and check your references in a timely manner, we may end up renting the property to another applicant. A properly completed application can be processed in a short reasonable time.
- What is the process if I am approved for a rental?
 - ➤ Once your application has been approved, you will need to sign and enter into a Residential Tenancy Agreement and any applicable addendums for the property you are about to rent. This contract outlines the terms, rate of rent, damage deposit amount, pet deposit if applicable, and length of tenancy.

- How much is the damage deposit?
 - ➤ One half of the month's rent. A move in inspection report will be done with you and the property manager just prior to move in and this report is signed to confirm the condition of the property.
- Are pets allowed? If so do I pay a pet deposit?
 - ➤ This varies from property to property if the owner allows pets. If yes then a pet deposit is required. Deposit can vary from \$250 to one half a month's rent, depending on the number of pets and size of the pets.
- Am I allowed to smoke in the property I have rented?
 - > Smoking inside the home is prohibited in all rental properties managed by Royal LePage Property Management. Failure to comply constitutes a breach in the terms of your tenancy.
- When is the rent due?
 - The rent is due on or before the 1st day of the month.
- How can I pay my rent?
 - You can pay your rent in person at our office by bank draft, or money order. <u>E-transfer is a preferred alternative and can be set up at the start of the tenancy.</u>
- When do I set up utilities?
 - Once you know your move in date, contact BC Hydro and Fortis BC to arrange for electricity and gas.
- When do I get keys for the property?
 - ➤ Once all the required paperwork is filled out, the inspection report is completed and the rent is paid in full.
- How do I report any maintenance issues once I take possession?
 - Non-emergency issues can be reported to the Property Manager by phone 250-997-6773, email realty09@telus.net or in person at our office during business hours. For emergency issues during business hours call 250-997-6773, after hours please call the same number for the property manager and follow the directions to be forwarded to a cell phone for assistance.

Please note: As recommended by the RCMP, if you intend to use this property for any illegal activities, we are committed to protecting the properties we manage from any possible damage that may occur due to marijuana grow operations. We can and will do spot inspections with 24 hours notice.
